"Parents" and "School" hereby agree to the following terms and conditions governing your Child's enrollment in Toddlerworks:

- Parent Accompaniment: In all such programs, parent(s) or guardian(s) must accompany, participate, and supervise child in all activities. If there is space available in the nursery school room for a sibling, a \$5 sibling fee will be charged.
- Non-Refundable Registration Fee: Parents herewith enclose the required non-refundable registration fee of **\$10.00** for the child named above. The registration fee is not refundable under any circumstances.
- Charges: At least 30 days prior to the commencement of the semester selected, parents must pay the entire tuition charge of \$_____ for the program selected. In the event that such tuition charge is not fully paid, Childworks will not admit the child or the parent/guardian into the program. There shall be no refund of such charges under any circumstances.
- Enclosure of Childworks: In the event that Childworks cancels the program or class in question for any reason, make-up days will be arranged to the extent possible within the semester.
- Student Injuries, Bathroom Needs, etc.: In the event the child has any needs whatsoever during the program, such as changing diapers, going to the bathroom, attending to an injury or illness, such shall be the sole and exclusive responsibility of parent or guardian. The parent/guardian is not to leave the child unattended for any time period during the program delivery.
- Permission for use of Photographs, etc.: Parents consent to use by the school of photographs, voice recordings, videos, and written extractions, in whole or in part, of Child named above, for the purpose of illustrations, advertising or publications.
- Termination of Agreement: The school reserves the right to terminate this agreement or to suspend child's attendance at any time, or from time to time, upon written notice to the parents that, in the opinion of the school, that further attendance of child would not be in either the best interest of child or the school, or if there is insufficient enrollment to sustain the program.
